Institutional strategies for the mobilization of funds and the optimal utilization of resources

The institute maintains and follows a well-planned process for the mobilization of funds and resources. The process involves various committees of the institute as well as the Department Heads and Accounts office. The institute has designed some specific rules for fund usage and resource utilization.

- Mobilization of Funds, the student Tuition fee is the major source of income for the institute.
- Various government and non-government agencies sponsor events like seminars and workshops.
- Alumni contribute to the institute by raising funds to purchase items like water coolers, wall clocks, etc.
- Sponsorships are sought from individuals and corporations for cultural events and fests.

Utilization of Funds

- The annual budget is prepared according to the needs and requirements of the departments taking into consideration the annual intake of students, laboratory and infrastructure development, faculty and staff requirements, promotions and latest technologies, etc.
- The college obtains proposals from the concerned departments regarding expenditure in an academic year, which is matched with the projected income for an academic year and is consolidated by the Principal of the College for approval by the Society that manages the affairs of the College.

- Once it is approved by the Society, the Principal apprises the Departments of the allocation so that re-appropriation of budget outlays are avoided or kept to the minimum. After the allocation, the departments can avail the financial resources within the given limit.

Resource Mobilization Policy and Procedure

- Before the financial year begins, the Principal and Heads of Departments prepare the college budget.
- The institutional budget includes recurring expenses such as salary, electricity, internet charges, stationary, and other maintenance costs.
- It includes planned expenses such as lab equipment purchases, furniture, and other development Expenses.
- The budget is scrutinized and approved by the management.
- Accounts department monitors whether expenses are exceeding the budget provision
- Statutory auditors are also appointed who certify the financial statements in every financial year.
- The grants received by the college are also audited by certified auditors.

Optimal utilization of resources

- The college aims at promoting research, development, consultancy, and such other activities, involving the faculty at various levels.
- The faculty are provided financial support to attend the National or International Conferences and present research papers in India or abroad, depending on the availability of funds.
- The optimal utilization is ensured through encouraging innovative teaching-learning practices.
- The college infrastructure is utilized as an examination centre for Government examinations/University Examinations.
